Neva Mike Feck email - suggests to define the club competitions. It is correct in the reasoning. A few years down the track, when the reasoning and intent is lost, you could have a committee member say I want Drifters to pay my entry to City of Sais, Jukebox, Wellington, Regionals etc

So should read:

'Drifters waive's the Committee's entry to Drifters Club Competitions and the annual Drifters Birthday Hop.'

So amendment to add "Drifters" before Club Competitions.

"Drifters waives the entry fee to the Drifters club competitions and the annual Drifters Birthday Hop for members of the current Committee"

Reasoning: To make the expectations of a Drifters member more prominent in the rules. *If rule change 1 does not pass, rule change 10 is not required.*

Label 'What is expected of you as a Drifters Member' section as Section 2.

Reasoning: To easily reference sections in the future

For competitors or supporters to receive subsidies, fundraising or sponsorship, they must be involved in Club activities and participate at club nights at regular intervals. Should a dispute arise about what constitutes an involved member, then the committee will determine this on a case by case basis.

Reasoning: To build in flexibility and to provide the current committee the ability to address current situations.

Reasoning: This will add clarity to the expectations and will align the Competition from Championships to Competition wording for consistency.

The definition of a dual partnership will remain in the rules (mentioned earlier in rule 11) to allow the section to be used at future Club Competitions (Club Championships / Competitions held/hosted by Drifters).

Any form of discrimination, harassment, sexual harassment, or bullying, whether verbal, physical, online, or alike is strictly prohibited. Members are expected to conduct themselves in a manner that promotes inclusivity and mutual respect during club activities and interactions. Violations of these rules may result in disciplinary actions such as warnings, probation, suspension, or expulsion from the club, depending on the severity and recurrence of the misconduct. The club values integrity and expects all members to adhere to these standards to ensure a safe and enjoyable experience for everyone involved.'

Reasoning: To elaborate on the current misconduct rules and guidelines to be more specific about what is not acceptable conduct by Drifters members.
